**Nunavut**  
Residents returning from Churchill, MB or Nunavik, QC for domestic leisure travel are not required to self-isolate; those returning from all other parts of Canada who are not fully vaccinated must isolate for 14 days at designated sites

**IV Inter-Provincial** 0

**Northwest Territories**  
Fully vaccinated residents returning from outside of the territory for domestic leisure travel are not required to self-isolate, but testing for those arriving in smaller communities; those who are partially vaccinated must self-isolate for 8 days and those who are unvaccinated for 10 days

**IV Inter-Provincial** 203.7

**Yukon**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**British Columbia**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**Alberta**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**IV Inter-Provincial** 213.2

**Saskatchewan**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**IV Inter-Provincial** 218.6

**Manitoba**  
Fully vaccinated residents returning from outside of the province for domestic leisure travel are not required to self-isolate; 14 day self-isolation required for those who are not fully vaccinated

**IV Inter-Provincial** 29.2

**Ontario**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**IV Inter-Provincial** 33.8

**Quebec**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**IV Inter-Provincial** 58.1

**New Brunswick**  
No self-isolation requirements for residents returning from out-of-province for domestic leisure travel

**IV Inter-Provincial** 22.4

**Newfoundland and Labrador**  
Residents returning from Atlantic provinces for domestic leisure travel are not required to self-isolate; those returning from other parts of Canada who are unvaccinated must self-isolate until receipt of a negative test result taken on day 7 or later

**IV Inter-Provincial** 7.9

**Prince Edward Island**  
Residents returning from Atlantic provinces for domestic leisure travel are not required to self-isolate if they have at least one vaccine dose and a PEI Pass; those returning from all other parts of Canada who are not fully vaccinated must self-isolate for 8 days and follow testing procedures

**IV Inter-Provincial** 8.8

**Nova Scotia**  
Residents returning from PEI or Newfoundland & Labrador for domestic leisure travel are not required to self-isolate; those returning from all other parts of Canada who are not fully vaccinated must self-isolate for 7 days and follow testing procedures

**IV Inter-Provincial** 11.5

Please note: An increase in search and bookings does not imply that residents are non-compliant with any current health restrictions in place, rather that there is an increased interest in travel. Actual travel could take place in the near future or at a later date.
